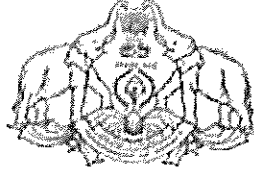

ORDER

As per Government order read as first paper above, Government had sanctioned time bound scales to statutory qualified Grade I Librarians who were promoted between 01.04.90 to 17.9.2004. As it was later seen that the above Government order, which was intended to rectify the monetary anomalies in respect of fixation of Statutory qualified Grade I Librarians will inadvertently result in extending undue benefits to Librarians, the same was kept in abeyance vide letter read as 2nd above.

2. Government have reviewed the earlier decision in view of various representations and are pleased to accord sanction, to the statutory qualified Grade I Librarian of Aided Colleges appointed/promoted between 1.4.90 to 17.9.04, by granting UGC scale of pay of Rs.10000-15300 (senior Scale) if they have completed 8 years of service in the post of Grade I Librarian as on 17.09.04 or as and when they complete 8 years of service, and scale of pay of Rs. 12000-18300 (selection grade) as and when they complete 16 years of service in the post of Librarian Grade I with future increments, subject to the following conditions.

- a) Notional fixation in the UGC scale will be given with effect from 17.09.2004 only (date of GO(Ms) No. 119/04/H.Edn dated 17.09.2004.)
 - b) Monetary benefit will be given with effect from 09.01.2012 only (date of GO(Rt) No. 63/2012/H.Edn dated 09.01.2012)
 - c) The monetary benefit will be given in cash from 01.04.2016 only. The arrears from 09.01.2012 to 31.03.2016 should be credited into PF Account.
 - d) Withdrawal of arrears from PF Account will be permitted from 1.04.2018 onwards. Those who retire in between will be permitted to withdraw the arrear on their closure of PF.”
3. The Government order read above is modified to the above extent.


